

### **PEBA will become Plannera on Jan.1**

On January 1, the Public Employees Benefits Agency (PEBA) will become a new not-for-profit corporation, called **Plannera Pensions & Benefits (Plannera).** PEBA is the plan administrator for Municipal Employees' Pension Plan (MEPP).

Plannera will operate at arms-length from government rather than being a government agency. This move will provide clear, streamlined accountability to all pension and benefit members and employers.

We want to assure you that your pension plan will not change. This means:

- your contribution rates, entitlements, and services will remain the same;
- The Municipal Employees' Pension Comission (Commission)

will continue to oversee the Plan; and

• The same world-class firms will continue to manage the Plan's investments.

PEBA has proudly served over 100,000 members in its 40-year history. The team is looking forward to this new chapter of serving pension and benefit members as Plannera.

# Cybersecurity 101: securing your digital world

As technology advances, it is important to be more secure and safe when browsing the web. Cyber security is about protecting your personal information and ensuring a safe online experience. Our Pension Information Officers are happy to assist you with any questions you may have about the security of your online member accounts. Here are some tips to stay safe while browsing the internet:

### Create strong passwords

Create passwords that are hard to guess by combining letters, numbers, and symbols. Avoid using easily accessible information like your birthday or name.

### Multi-Factor Authentication (MFA)

Enable MFA on your accounts that give you the option to. It adds an extra layer of protection by requiring two forms of identification before granting access. MFA is mandatory for all users on the MORe Planner to ensure that members stay safe online!

### Be cautious with downloads

Only download files or software from reputable sources. Avoid clicking on pop-up ads and unfamiliar links as they might contain harmful malware.

### **Beware of Phishing**

Be cautious of emails or messages asking for personal information or login details. If something seems suspicious, verify it with the sender through a trusted source. Our Pension Information Officers would never ask you for your password.
